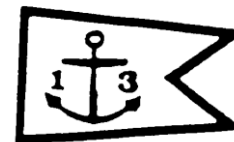

VISITOR'S DOCKAGE AGREEMENT

1. THIS AGREEMENT IS FOR THE USE OF DOCK SPACE ONLY. Such space is to be used at the sole risk of the owner.
2. H.R.Y.C. shall not be liable for the care or protection of the boat, including her gear, equipment and contents, or for any loss or damage of whatever kind or manner to the boat, her contents, gear, and equipment.
3. OWNER INDEMNIFIES AND HOLDS H.R.Y.C. HARMLESS AGAINST ANY LOSS, COST, SUIT OR ANY CLAIM ARISING OUT OF USE OF PIER SPACE OR ANY HANDLING OF THE BOAT IN CONNECTION THEREWITH WHETHER OR NOT SUCH LOSS, COST, SUIT OR CLAIM IS BASED UPON THE SOLE NEGLIGENCE OF H.R.Y.C. OR OTHERWISE.
4. Boat owners are responsible for damage to H.R.Y.C. dock structures and pilings. In the event of an emergency, H.R.Y.C. reserves the right to move boats to other mooring places.
5. It is expected that boat owners keeping their boats at H.R.Y.C. during the hurricane season will have made arrangements for the safe and sheltered anchorage of their boats elsewhere on the approach of the storm. In the event of a tropical storm, H.R.Y.C., at the discretion of the Dockmaster, Flag Officers, or Club Manager, reserve the right to evacuate unattended boats at the owner's expense and risk. However, nothing contained herein shall require H.R.Y.C. to do so.
6. The owner agrees to comply with the dock/house rules provided with the agreement. Breach of this agreement or violation of these dock/house rules is cause for immediate termination of the agreement. In such cases, H.R.Y.C. may remove the boat from her space at the owner's risk and expense, and retake possession of the space.
7. H.R.Y.C. shall have lien against the boat, her appurtenances and contents for unpaid sums due under this agreement. The boat owner and the vessel shall have an additional liability for all costs and expenses incurred in the enforcement of any provision of this agreement, including collection of unpaid sums, giving H.R.Y.C. the right to collect its attorney's fees and proceed against by legal judicial sale or non-judicial sale in accordance of Florida law including but not limited to Florida Statutes #5.021 and 324.17.
8. Check out time is 12:00 noon unless prior arrangements are made.
